MEDICAL INSTRUCTION

- Do not consume anything by mouth 3.5 hours prior to your procedure (Step 7 should be done within 30 minutes).
- If you do not have regular, daily bowel movements, or are on a GLP1 medication, purchase additional Miralax over the counter and drink 2 capfuls of Miralax every night for 5 days prior to your procedure to have a successful exam.
- If you take a prescribed blood thinner, you will need holding instructions from our office.
- If you have <u>diabetes</u> or are taking medications for weight loss, use the following instructions:
 - Insulin Pump: Leave on, if you have questions refer to your endocrinologist.
 - Long-acting Insulin: half dose the evening before procedure. Do not take the morning of your procedure.
 - Short-acting insulin: dose as necessary with blood sugar monitoring.
 - Oral diabetic medication: do not take the morning of your procedure.
 - GLP1: Do not take the day of your procedure (may take day before or day after).

FOR YOUR PROCEDURE

- 5 Days before: No nuts or seeds. Stop all iron supplements, fish oil, CBD oil, or any oil-based supplements.
- You will be sedated for your procedure and will need a driver to take you home. If your driver wishes to discuss the results of your procedure with the doctor, please have them remain on site.
- You will not be able to drive, work, operate equipment or anything else that requires judgement or reflexes for the rest of the day.

Helpful Tips:

- Do NOT drink any fluids 3.5 hours prior to your exam.
- You do not have to eat all the food in the kit but you do need to drink all the laxatives. You must complete your entire bowel prep. We often see poor bowel preparations because patients stop drinking fluid.
- If you finish the whole prep and your stool is brown, thick, or not clear call us for advice.
- If you are nauseated or vomit with the prep, stop drinking to allow your stomach to settle before continuing.
- You may not remember your conversation with your doctor after your procedure we STRONGLY recommend your driver stays IN our facility to speak with the doctor after your test.

Your procedure time will be approximately 90 minutes from the scheduled check-in time to discharge for procedures in the Meridian, Boise, and Canyon County Endoscopy Centers. Please coordinate with your driver to alleviate delays in discharge. Patients' stay times for hospital procedures may be longer.

We cannot be responsible for your valuables (watches or various jewelry items). Please leave them at home.
